- 1. Education Committee is chaired by the Director of Education at present
- 2. The Director of Education is the only sabbatical officer who chairs an Association Subcommittee at present
- 3. The current SRC Faculty Presidents have been acting chairs of Education Committee since Week 1 of Semester 2
- 4. The official role description of the SRC Faculty Presidents states that "The aim of this position is to represent undergraduate students on academic matters at a University-wide level and to provide support for the Director of Education and School Presidents."
- 5. The installation of the Faculty Presidents as acting chairs of Education Committee has significantly supported the Director of Education and further strengthened the working relationship between the Faculty Presidents and School Presidents

Believes

- 1. Education Committee can be effectively run by a non-sabbatical officer
- 2. The installation of the Faculty Presidents as chairs of Education Committee helps to formalise the aspect of their role description which pertains to the provision of support for the Director of Education and the School Presidents
- 3. The installation of the Faculty Presidents as chairs of Education Committee increases the visibility of their role among the academic representation community
- 4. When chaired by the Director of Education, Education Committee is unable to meet during certain periods, due to the Director of Education's other commitments

- 6.1.3. Represent the views of their constituency to the SRC, the Academic Council and the Senatus Academicus;
- 6.1.4. Be a member of Act as chair of the Education Committee, be a member of Education Executive Committee, and Student Opinion on Academic Council (SOAC);
- 6.1.5. Attend the School Presidents' Forums; and
- 6.1.6. Liaise with the Director of Education on supporting School Presidents and other academic representatives.
