It is noted that:

- 1. The Societies Committee currently has a Webmaster, whose responsibility is to maintain the Societies Portal.
- 2. The Societies Portal has not existed for the past three years.
- 3. No Webmaster has been elected officially in the past three years.
- 4. The Societies Committee currently has an Events Officer, whose responsibility is to assist societies with hosting events and any questions they have with events planning.
- 5. The Societies Committee has multiple social media profiles, but none of them are maintained and they are only used for events such as Societies Awards.
- 6. Grant applications from societies have decreased consistently in the past few years.

It is believed that:

- 1. The role of Webmaster no longer has any significance to the committee and should be removed.
- 2. Societies are not engaging with the role of Events Officer since its responsibilities are overlapped with DoES and ENTS. Events Officer should therefore be removed.
- 3. The role of Publicity Officer will increase Societies Committee's social media presence and improve grant application numbers.

It is resolved to:

- 1. Update chapter 25 of the Laws (Appendix A) and replace it with Appendix B.
- 2. Remove the role of Webmaster.
- 3. Remove the role of Events Officer.
- 4. Add the role of Publicity Officer.
