Cycle Safety Report for SRC Meeting 15.11.16

The purpose of this report is to outline the issues regarding cycle safety in St Andrews, what is currently being done to address this and potential options for future action.

The problem:

In Scotland, the number of cycles on the road has increased by 46% since 2004 and the number of cyclists injured in a road accident has increased by 14% since then with 888 cyclists injured on the road in 2014. (roadsafetyscotland.org.uk)

In St Andrews, dangerous cycling is one of the most common complaints about students from locals including habits such as cycling without correct lights; cycling on the pavement or in the wrong direction on one way streets and dangerous overtaking -particularly on roundabouts. It must also be considered that many drivers in St Andrews drive in a manner that puts cyclists at risk, again in particular at roundabouts.

Lara Fahey, the Campus Cycling Officer recently did a bike light survey and found that 25% of cyclists in St Andrews do not have any lights and a further 16% only have one light. **Some of the laws:**

- At night your cycle MUST have white front and red rear lights lit. It MUST also be fitted with a red rear reflector (and amber pedal reflectors, if manufactured after 1/10/85)
- You MUST NOT cycle on a pavement
- You MUST obey all traffic signs and traffic light signals
- You MUST NOT ride in a dangerous, careless or inconsiderate manner
- You MUST NOT cross the stop line when the traffic lights are red

Police Scotland provide cycle safety advice on their website and are supporting the national *Give Everyone Cycle Space* campaign to encourage drivers to take extra care around cyclists.

Police in St Andrews are conducting a cycle safety campaign in town over the next three weeks to encourage cyclists to use lights and wear helmets

The University shop provides cost price bike lights but there are only 149 left (as of 1pm 11.11.16) at this reduced cost.

The Community Relations Committee are working with the **Campus Cycling Officer** on a bike light campaign that will start with posters and may expand to running events. **Transition** have made a promotional cycle safety video

What could be done?

Some ideas that were floated at the recent Bicylce User Group meeting are:

- Putting cheap, clip on lights onto every bike without them
- Finding ways to push local bike shops to encourage students to buy lights
- Bike Pool refusing to fix bikes without lights/otherwise promoting lights
- Increased Police spot checks
- Working with Business Improvement District (BID) to publicises which shops bike lights are sold in
- Targeting University staff as well

Finally, I have contacted the PGR and PGT specific Careers Advisors as well as Alex Griffiths in Registry, inviting them to the Postgraduate Development meetings and have so far received positive responses.
