J.15-14 A MOTION TO REFORM ALUMNI ACCESS TO THE UNION

OWNER: Pat Mathewson

IN EFFECT FROM: Immediately **REVIEW DATE:** April 2016

THIS SSC & SRC NOTE:

- 1. The Association's Strategic Plan holds 'engaging with alumni in a meaningful way' as a core objective of our three year strategy.
- 2. Efforts are currently underway to make a student-driven alumni approach a reality, including the forthcoming Alumni Festival Weekend in April 2015.
- 3. Barriers still exist to the ease with which Alumni can access the union, relying principally on the mechanism of Life Membership.
- 4. Revenue from new and replacement Life Memberships issued in this academic year totalled £145.
- 5. There is an insufficient mechanism for data capture of which alumni are visiting the union.
- 6. The union has until now had no database to verify the authenticity of an alumnus who presents at the door on a given evening. This has now been rectified with the assistance of the Development Office.

THIS SSC & SRC BELIEVES:

- 1. Successful engagement with alumni has the potential to significantly enhance the Association and the delivery of its mission. Furthermore, increased footfall has the potential to support commercial objectives.
- 2. The success of events such as the forthcoming alumni festival weekend will rely on a user-friendly and efficient means of giving alumni access to the Union. The year on year success of these events will be enhanced by robust data capture.

THIS SSC & SRC RESOLVES:

- 1. To Strike Section 3.2.1.2 from the laws "On payment of the appropriate fee as determined by the SSC."
- 2. In keeping with licensing laws, to mandate that door staff utilise the new database to verify the identity of alumni in enabling access to the Union.

J.15-15 A MOTION TO HOLD NUS REFERENDUM

REVIEW DATE: N/A

THIS SSC & SRC NOTE:

- 1. That the University of St Andrews Students' Association is not presently affiliated to the National Union of Students (NUS).
- 2. The referendum held in November 2012 on the question of whether the Association should affiliate to the NUS, which resulted in a vote of 75% against to 25% in favour
- 3. That in an amendment to the motion initiating the above referendum, the SRC resolved to hold another such referendum in three years' time.

THIS SSC & SRC BELIEVES:

- 1. That the question of whether to affiliate to NUS is best decided by the students of St Andrews by means of a referendum.
- 2. That it should respect the decision of the previous SRC on the timing of this referendum.

THIS SSC & SRC RESOLVES:

- 1. To hold a referendum on 19-20 November 2015 on the question "Should the University of St Andrews Students' Association join the National Union of Students? Yes or No."
- 2. To request the Students' Association Board (SAB) to commission independent information on the costs of affiliation, to be published as part of the referendum campaign.
- 3. To instruct the Elections Committee to draw up rules for the conduct of campaigns during the referendum.
- 4. To hold another NUS referendum, regardless the result, in November 2018.

A MOTION TO LOBBY FOR ADEQUATE PROVISION OF SEXUAL HEALTH SERVICES IN ST ANDREWS

THIS SRC NOTES:

- 1. That the NHS Sexual Health Fife runs a Contraception and Sexual Health Clinic every Tuesday 12.30-4.30pm during term time in Eden Court.
- 2. The Director of Representation and the Wellbeing Committee received numerous complaints from students about the long waiting time, exceeding 3 weeks, in the Eden Court Contraception and Sexual Health Clinic.
- 3. The University of St Andrews Student Services have been in discussion with NHS Sexual Health Fife about expanding the provision of the Contraception and Sexual Health Clinic for over 12 months.

THIS SRC BELIEVES:

- 1. The promotion of positive sexual health is an important responsibility of the Students' Association.
- 2. The NHS Sexual Health Fife should ensure adequate provision of sexual health services for members of the Students' Association and the wider community.
- 3. The long waiting time at the Contraception and Sexual Health Clinic in Eden Court is detrimental to promotion of positive sexual health in St Andrews.

THIS SRC RESOLVES:

- 1. To express support to the efforts of Student Services to increase the provision of sexual health services at the Contraception and Sexual Health Clinic.
- 2. To mandate the Wellbeing Committee to lobby NHS Sexual Health Fife and other appropriate bodies on expanding the Contraception and Sexual Clinic in Eden Court to reduce waiting time and ensure adequate provision of sexual health services in St Andrews.

SRC REPORTS

ARTS/DIVINITY FACULTY PRESIDENT- CHARLOTTE POTTER

I have been organising a conference on women in academia over the past year, and it will take place on 16th April. This has therefore been taking up the lion's share of my time as Arts and Divinity Faculty President over the last few weeks. Before the break, on March 10th, I attended the first Academic Council of the semester, where I spoke on matters including Admissions and Widening Access, and contributed to the discussion of the strategic plan, commenting on the importance of preserving the student experience in the face of increasing student numbers and the current accommodation crisis. Together with Katy, the Science and Medicine Faculty President, we are attempting to wrap up several ongoing projects, focus on the handover for the incoming Faculty Presidents (especially important as they were new roles this year) and planning some end of year social events for the Education Committee.

ASSOCIATION ALUMNI OFFICER- CHARLOTTE ANDREW

This week I've met several members of the Development Office team alongside Pat, discussing plans for the Alumni Festival Weekend. We've also met with other members of the Development office focusing on the possibility of starting up a crowd fundraising website to aim at condensing all alumni donations to society projects into one platform. Not only will this clarify the process for students and alumni, it will also allow the Development Office to track the number of donors and amount of donations made over the year. This helps consolidate rankings of the University in terms of Alumni engagement. In the next few days I am to organise meetings with SSC subcommittee heads to focus on improving their current processes of alumni engagement; including sending out newsletters and creating an alumni database.

ASSOCIATION COMMUNITY RELATIONS OFFICER- CLARE ARMSTRONG

This week I have been liaising with the local branch of RBS regarding an upcoming event they are holding with Police Scotland for those in the area who might be vulnerable to crimes such as scams and phishing, and I am hoping that we will be able to make this advice available to our student body later on. Additionally, I am shortly to attend the first meeting of the Safer Campus Group, which aims to tackle issues of substance misuse and anti-social behaviour within the university, and I am confident that this will provide an effective means to address these issues in the future. Other than this, I have also helped to set up a separate email account for Community Relations Officer, which should help to aid institutional memory, and I am looking to start setting a budget for community relations projects in the near future.

At the School Presidents' Forum on Monday 30th June, we discussed the antidistraction campaign organised by a collection of FPs. We further discussed joint-Honours dissertations and potential additions to the Collaboration statement with the Proctor and the Deans. Industrial Placement tuition fees were on the agenda, but progress is limited because of restrictions by the British Government.

Outside of this meeting, I've had some discussion with the DoRep and School Presidents concerning potential changes by the University to the Entry to Honours policy for Science students (the University are trying to make practices more standard across the Faculty).

We're essentially trying to eliminate the issue of self-selecting focus groups by going through this process.
- -Committee Rebrand In order to expand our outreach and attract wider audiences for our events, services, and campaigns, we will be centralising all of our information onto a new website featuring bios of each committee member, contact information, past and upcoming events, a list of relevant resources for students, and our full strategic plan. All of this content will be pushed via social media as well as word-of-mouth publicity.
- -Strategic Planning One of the major issues on the Equal Opportunities Committee this year was the lack of an overall agenda which directed the activities of the group. In order to address this, we will spend the last two weeks of term drafting a three-year strategic planning document which will highlight our main aims as a committee with regards to events, resources, services, policies, and campaigns.

- meeting with incumbent SRC Employability Officer in order to facilitate handover and to gain insight and draw upon her past experiences (before Spring Break)
- meeting with DoREP to discuss ideas and plans for the future as well as explaining the position of SRC Employability Officer within the Students' Association (before Spring Break)
- meeting with the Director of the Career Centre, Paul Brown, scheduled to discuss cooperation for next year as well as exchanging ideas (date tbc)
